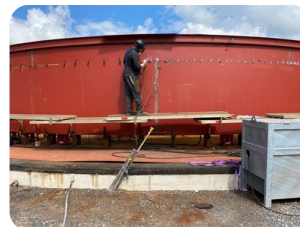
EXPANDING TOGETHER

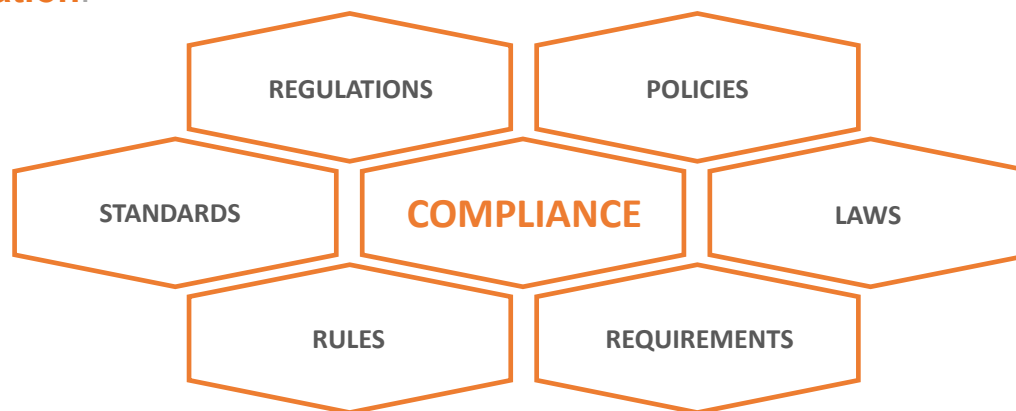

Our operational management services include **personnel management, the planning and processing of maintenance and restoration.**

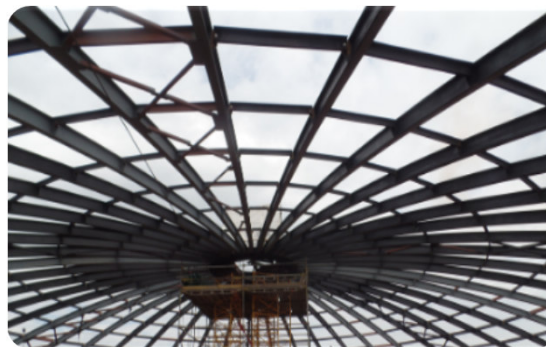

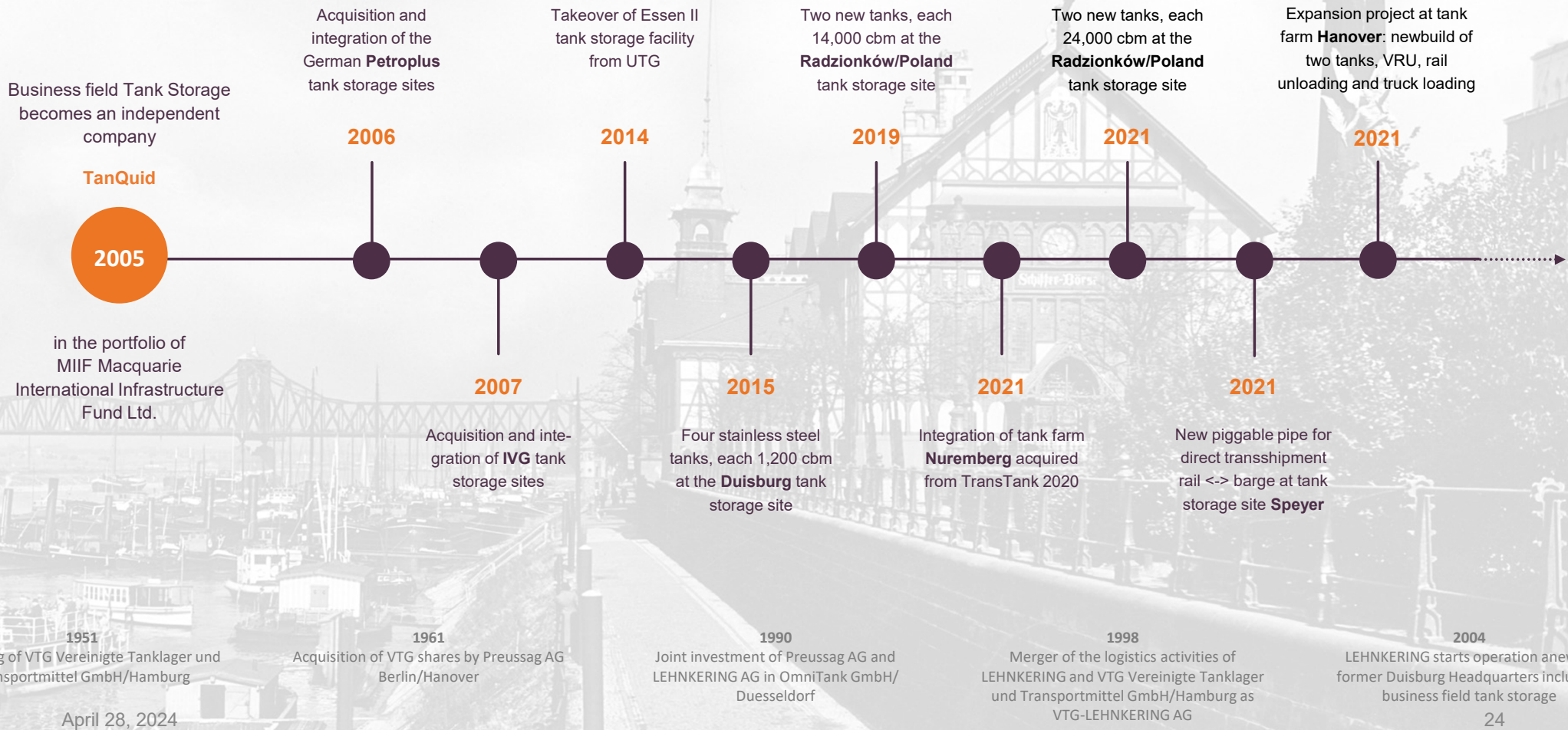
